2. BACKGROUND & POLICY CONTEXT OF ISSUE: A portion of the student registration fee collected by each institution is used to support the State Supported Operating Budget for higher education. The remainder of the registration fee revenue is retained by the institution to provide for Student Access (need-based financial aid), as well as other institutional and student related needs, including General Improvement, Capital Improvement, Activities and Programs and Student Government. Recommendations for the allocation of student registration fee revenue among these categories for academic years 2023-24, and 2024-25 are outlined in the schedule that follows (Attachment A).
3. SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED: The Officer in Charge and Presidents request Board approval for the distribution of the registration fee for academic years 2023-24 & 2024-25, as shown on the attached schedule.
