Esteemed Board of Regents,

My name is Tyler and I am a part-time instructor at Truckee Meadows Community College and have worked for Nevada System of Higher Education since 2020.

I'm writing today because I am concerned about a recent proposal that will increase the pay for graduate assistants through NSHE while excluding part-time faculty from this pay increase. Part-time instructors at TMCC teach about 45% of classes and are a vital part of the academic community and retention efforts throughout NSHE. In a survey we conducted two years ago at TMCC, we noted that over 70% of part-time instructors are concerned that they are not compensated for the level of education they have. If NSHE is considering a pay increase for graduate assistants, who may have fewer academic qualifications and less experience compared with part-time faculty, how is this equitable?

As a part-time instructor, I am not paid enough to meet basic needs. We are only paid a stipend amount for the amount of time spent in the classroom. Thus, we are not paid for

additional time put into keeping our classes updated and running. I do not get additional compensation for taking more time to assist students outside of classroom hours, for improving existing lectures, and spending the time to ensure we do our best to educate our students.

Nationwide research suggests that 40% of part-time faculty struggle to meet basic needs, about 25% of adjuncts rely on public assistance, and only about 15% of adjunct faculty say they can comfortably provide for themselves. How can part-time faculty be treated ethically if they are living in poverty? If pay increases are only for graduate assistants, this will devalue part-time faculty. I urge you to include part-time faculty in this pay increase and remember that the NSHE institutions are reliant on part-time faculty to continue moving forward. You have an opportunity here that I hope won't be missed.

NSHE Institutions starting salary for an Administrative Assistant I is (13.09/hr.) The City of Henderson and Clark County salary

almost doubles what an AA 1 makes for NSHE. As the Vice-Chair of the Classified Employee Council for Nevada State, I stand for every NSHE Classified Employee today. I fully support the NSHE Board of Regents Anti-Discrimination Resolution. As you consider your vote on this issue, please consider the following points: •This resolution documents the values and expectations not only the NSHE Board claims to value but that students and employees of all NSHE institutions are expected to reflect, practice, and develop (i.e. employee job postings or student code of conduct). Why should our elected Regents – Leaders – not be held to the same values and standards in their roles that directly shape our NSHE system?•The resolution addresses the importance of maintaining freedom of expression while still committing to anti-discrimination values and behaviors. Both can be valued and executed – they are not mutually exclusive. •This resolution sets a precedent for how we support students in persisting and graduating from any Nevada college/university in any role. For example, in my role I am required to assess the impact of our academic services (e.g. free accessible tutoring). Campus data shows that students who use our tutoring services earn higher GPAs and graduation rates than students who do not (regardless of incoming high school metrics). This is great but if I stop there, I miss some important student experiences that

are NOT reflected in that one data snapshot. In using an ant-discrimination/equity lens, I have learned to ask additional questions like, who is left out from what this data set is showing and why? Asking/answering such questions ensures holistic support which Regents should apply to their roles as well. Supporting this resolution takes a clear stance against discrimination. It is not enough to "not be discriminatory", Regents must commit to learn how to be actively anti-discriminatory through the resolution guidelines.
