UNR/GBC Shared Services Agreement

The Board of Regents approved the MOU agreement between GBC and UNR in June 2019 to provide a framework to create pathways for rural students to augment their educational opportunities to access upper-division biology and health science graduate studies. In addition, leverage shared services in business services, human resources, information technology, facilities, real estate, and police services. By creating this agreement, GBC focused and successful strategic alliances with UNR over the last four years in various aspects of GBC's business and academic operations. A notable partnership is being created and sharing training facilities for the Mining Center of Excellence, where GBC collaborates with UNR Mackay School to jointly serve the mining industry for research, academic, and training opportunities. Today we wanted to update you on the new and existing consolidation of services between UNR and GBC.

- Agreement: To accommodate GBC students who wish to spend a semester on the UNR
 campus taking upper-division biology classes. This attachment is established to allow
