Comment:

The sale of UNLV land to the Boring Co. does nothing to improve the student experience and while there are claims that it would help alleviate issues of traffic and transportation the use of Tesla taxis presents numerous safety hazards and failed promises. Tesla vehicles have an established history of combusting in a manner that traditional firefighting equipment can not address, doors that can not be manually opened without specialist knowledge or a complete examination of the vehicle or its owners manual, and the current tunnel has drawn criticism for a lack of accessible and properly marked emergency exits or even adequate lighting. Additionally, the current existing tunnel has yet to meet the expectations set by the Boring Co., with the existing tunnel to the Las Vegas convention center failing to meet the advertised sub-three minute transit time for CES '21 even during a decreased attendance due to CoVid resulting in the possibility of financial penalties. The Boring Co. also has stated that they intend to have 60+ installations in the Las Vegas area but has only constructed one major destination stop. The proposed sale of UNLV land to The Boring Co. reflects a lack of awareness of the Nevada University system. While the sale of this land could provide a financial boon, I and other members of the former and current UNLV student population have

seen that funds are repeatedly spent on things that do nothing to provide a more fulfilling, comfortable or safe attendance at NSHE schools. Please refer to the President of UNLV receiving a housing and vehicle allowance alone larger that exceeds twice the income of many students who work while attending and the constant expansion of UNLV's athletic programs with the football team failing to win a conference or division championship in 10 years. All while dorms fall apart to the extent of raw sewage leaking into the floors of Tonopah dorms, and students are food insecure to the point of requiring a food pantry.

Hi and thank you for your time. My name is Staci Walters. I am CSN faculty, an NFA member and a Negotiator for CSN's current collective bargaining agreement. I am here to address salary equity at the community college level, on the heels of recent salary studies completed by NSHE and CSN.

Some facts: faculty at CSN were removed from a step system years ago. I repeat, there is no step system and no built-in base salary increases. Raises were stagnant for over a decade and have increased less than 3% over the past 5 years.

Faculty look toward the Regents to uphold NSHE Handbook regulations around completing regularly scheduled salary equity studies. The most recent NSHE-system study on community college faculty was deemed inconclusive, even while administrators received large increases. The most recent CSN salary equity study had major data flaws and faculty were steamrolled when they brought up questions and concerns. It's been over a year since the study was completed, and many faculty have outstanding appeals.

We are currently supposed to be amidst an NSHE mandated, CSN ran salary equity study. That study has not been initiated, and admin stated that they do not intend to complete this year's study. With inflation at its highest, wages stagnant, and ignored concerns on salary

equity, faculty are at a loss.

We implore you to uphold NSHE code, immediately initiate the CSN salary equity study, and support the faculty bargaining efforts during this summer's contract negotiations on base salary increases. We must retain faculty and keep employee retention high. Your faculty feel demoralized and over 50% statewide are continuing to look for other employment. Supporting faculty growth is the fastest way to empower the CSN community to achieve, succeed, and prosper.

Should the Board choose to vote against Nevada State's name change, they are openly standing in favor of inequitable treatment of graduates who earn their bachelor's or master's degree from Nevada State. The Board's purpose is to act in the interest of ALL institutions under the NSHE umbrella, not to show favor to only one institution (UNR) within the system. There is overwhelming support from Nevada community and businesses, the majority of other NSHE institution leaders (Sandoval seems to be the only one NOT in favor), and local and federal state representatives. I urge the Regents to do their job, to stand up for all institutions, and not be swayed by a single institution's president.
