The great majority of TMCC faculty are off contract, and I suspect most are unaware of this proposal being considered to extend Dr. Hilgersom's contract, possibly without an evaluation. Frankly I think we all find the timing of this proposal remarkable because just a few months ago, when we were all still on contract, faculty leadership was given assurances by Dr. Hilgersom and the Chancellor that the evaluation process for Dr. Hilgersom was most definitely happening.

It appears NSHE has been provided a choice for her departure date. I agree with those advocating for a process that leads to a 2-year departure for Dr. Hilgersom, because 2 is less than 5. I also believe that the evaluation process is very important and is legally required by the NSHE Code. Everyone should be accountable through a regular evaluation process. Another strong rationale for her evaluation is the comprehensive Climate Survey that was recently done by the Nevada Faculty Alliance for all the NSHE institutions. The Climate Survey results made it abundantly clear that TMCC has a serious morale problem, and that the great majority of employees attribute a big part of it to the administrative leadership.

To summarize, I think that the evaluation is important and is required, however, I don't believe the evaluation should become a deal breaker and should not impact the date of her

departure. She has expressed a desire to leave the college and we fully support her in this matter, sooner rather than later.
