In accordance with Attorney General Opinion No. 00-047, as restated in the Attorney General's Open Meeting Law Manual, the Board Chair may prohibit comment if the content of that comment is a topic that is not relevant to, or within the authority of, the Board of Regents, or if the content is willfully disruptive of the meeting by being irrelevant, repetitious, slanderous, offensive, inflammatory, irrational or amounting to personal attacks or interfering with the rights of other speakers.

2. APPOINTMENT, INTERIM CHANCELLOR <u>FOR POSSIBLE ACTION</u>

At its June 30, 2023, meeting, the Board took action to discontinue the search for Chancellor and begin the process to appoint an interim Chancellor. Pursuant to the NSHE <u>Code</u> (Title 2, Chapter 1, Section 1.5.4(d)), within sixty (60) days of the Board's request, the Chair and Vice Chair shall recommend to the Board an individual for consideration and appointment. Prior to making the recommendation, the Chair and Vice Chair shall first meet with major constituencies of the NSHE, including presidents and faculty senate chairs, to receive their suggestions and input for the appointment. Chair Brooks will provide an overview of the meetings and conversations held to receive input and suggestions concerning the appointment of an interim Chancellor.

If an interim Chancellor is appointed, the Board shall determine whether a search will be conducted, or if an interim Chancellor will be appointed to a specified term of one to three years (*Title 2, Chapter 1, Section 1.5.4(e)*).

Chair Brooks and Vice Chair Arrascada will recommend for consideration and approval by the Board the appointment of Patricia Charlton to serve as interim Chancellor for a specified term of one (1) year. Alternatively, the Board may consider the appointment of Patricia Charlton as interim Chancellor and commence a search, in which case the interim Chancellor would serve until a permanent Chancellor is appointed at the conclusion of the search process.

The Board will conduct an interview with the recommended candidate prior to considering the appointment. The Board may also consider approval of the proposed Employment Agreement.

2. APPOINTMENT, INTERIM CHANCELLOR - FOR POSSIBLE ACTION (continued)

If no action is taken, the Board shall consider whether it will request recommendations for an acting Chancellor or an interim Chancellor following the procedure set forth in Board policy (*Title 2, Chapter 1, Section 1.5.4(d)*). The officer in charge shall exercise the powers of the Chancellor until an acting or interim Chancellor is appointed by the Board (*Title 2, Chapter 1, Section 1.5.4(c)*). (*Ref. BOR-2*)
