#### **Comment:**

Doug Unger, President, UNLV Chapter, Nevada Faculty Alliance. Over the two and a half centuries of the American experience founded on ideologies of individual liberty and freedom, I feel we have somehow sacrificed humane values to the cult the individual. And so we became a society self-concerned to the exclusion of what we should hold most dear: worksharing, helping hands to one another, the education and even the lives of our children. When did it become socially normative on the excuse of freedom to address individual grievance with guns? Or to embrace the American fetish of the gun instead of reviling those who wave them around and brag about them like perverse male jewelry? Our humanity feels imprisoned by a cult of guns.

After the mass shooting on the UNLV campus on December 6th, our faculty, staff, and students no longer feel safe. We grieve the murders of three beloved teachers, all minority professors resonant with our diverse campus—Dr. Patricia Navarro-Velez, Dr. ChaJan "Jerry" Chang, and Dr. Naoko Takemaru, also our Visiting Professor wounded and still fighting for his life. It feels inconceivable to return to a campus with bloodstained halls, bashed-in doors, broken glass and triggering memories, but we know we must. We ask emergency assessments of campus security for all NSHE campuses for optimal safety; that all safety plans must include faculty, staff and student input before they are approved. We ask the Governor and Legislature for an expedited appropriation of several millions these safety improvements will cost above what insurance pays. We ask our fellow citizens to join us in anger, no, rage

enough so that we never stop fighting this prison of gun violence, never, until each woman and man is free, until we are held all together in the custody of our humanity.
