HANDBOOK REVISION: Residence Hall and Food Service Rates

BACKGROUND & POLICY CONTEXT OF ISSUE:

Title 4, Chapter 17 of the Board of Regent's *Handbook* outlines the Residence Hall and Food Service rates for UNLV, UNR, and GBC. This requested change is a clarification that the approval process for residence hall and food service rates excludes conference or other activities that are not exclusively for enrolled students.

SPECIFIC ACTIONS BEING RECOMMENDED OR REQUESTED:

Amend the provisions of Title 4, Chapter 17, excluding residence hall and food service rates for conferences or other activities that are not exclusively for enrolled students. (See attached Policy Proposal.)

IMPETUS (WHY NOW?):

This proposal is brought forward in conjunction with the annual special fees review process and is being requested to clarify which residence hall and food service rates need Board approval.

BULLET POINTS TO SUPPORT REQUEST/RECOMMENDATION:

Updating the *Handbook* to reflect this clarification eliminates the need for Board approval for conference and related event rates and reflects the preferred business practices of the institutions.

Section 21. Residence Hall and Food Service Rates~~[, UNLV]~~

The Board of Regents shall approve [all] residence hall and food service rates for [the University of Nevada, Las Vegas] *all NSHE institutions, excluding rates for conferences or other activities that are not exclusively for enrolled students.*

~~The Board of Regents shall approve all residence hall and food service rates for the University of Nevada, Reno.]~~
